community rallies in support of our MA community.



As part of our commitment to taking care of our immigrant worker community, the BWC understands that the empowerment of immigrant workers starts with us. For this reason, our Executive Director, Lenita Reason, has invited professionals from our community to administer two very important capacity training for our BWC staff: Know Your Rights led by Thomas Smith and his legal team and Social Media Training for NGOs led by digital marketing expert, Alexandre Simões.

In the Know Your Rights workshop, our team had the opportunity to expand our knowledge associated with Workers Rights in MA and relevant information about wages and benefits as per MA legal requirements. Participating in this type of training was and is essential to maintaining our team informed about changes in legislation that may affect immigrant workers and keep our team ready to attend to the needs of our community.

At the BWC, we know that it is important that we have a strong social media presence to best represent the services we provide as well as the impact of our work in the community. Therefore, capacitating our BWC team is imperative to accomplish this goal. We are proud to have received Social Media training on March 12th, 2022, which provided us with invaluable information about how to create intentional targeted posting that is relevant to our audience and contributes to disseminating information about our organization.

By having our team engage in regular capacity training, the BWC will be able to return this knowledge to the community and continue to honor our mission: to capacitate immigrant workers to learn about workplace rights, immigration and health equity and empower immigrants with knowledge and skills to promote economic, social, political, and racial justice for all.

### Where there is OSHA, there is excellence!



As part of our partnership agreement with the Occupational Safety and Health Administration (OSHA), the Brazilian Worker Center participates in regular meetings to provide updates about our OSHA funded training programs. On March 11th, 2022, we had the pleasure to welcome Mr. Peter Baeta to our organization in Allston, MA. The BWC is proud to have been a recipient of OSHA's funding in support of our Fall Prevention training for construction workers for over 11 years and for having received funding from OSHA in support of our Infectious Diseases and COVID-19 training for immigrant workers. It is because of this long-term partnership that BWC is able to offer and sustain the only Portuguese-speaking Fall Prevention

capacity training program for construction workers in the country. This program is also offered in Spanish at BWC. We look forward to continuing our collaboration with OSHA and to sharing more updates throughout the year.

#### BWC talks the talk and walks the walk!

It is not just important for us to teach our immigrant worker community the importance of organizing as a way to advocate for our rights, but it is imperative that we join our community whenever it needs us the most.

On March 12th and 15th, the BWC stood proud with members of our community, respectively, in defense of delivery and ride-share drivers' right to be classified as employees instead of contractors, and endorsing the Coalition for a Just Allston + Brighton (CJAB). On March 12th, the BWC's Executive Director, Lenita Reason joined Congresswoman Ayanna Pressly, State Senator Lydia Edwards and the "Massachusetts is Not




For Sale" group, as they voiced their support for workers and other community activists against big tech exploitation of app-based workers. And, on March 15th, Lenita publicly endorsed the CJAB in their efforts to unite Allston-Brighton residents and leverage their voices on behalf of mutually beneficial relationships with Harvard, the single-largest landholder in Allston/Brighton, as it seeks to develop its 360 acres of land in these neighborhoods.

The BWC's presence in these community-led initiatives and campaigns is a testament of our organization's commitment to accelerating the betterment of our immigrant communities and quality of life in the State. We are honored to have participated in these campaigns and we continue to stand together with our MA community in the fight against social, economic, and political injustice.

## BWC joins the coalition to protect injured workers' rights!

On March 23rd, BWC's Executive Director, Lenita Reason, participated in a Zoom meeting with other worker groups and advocates as part of the coalition that supports An Act to Protect Injured Workers. This act is very important as it fights on behalf of injured or ill workers, as the law still leaves them large-ly unprotected when employers retaliate against them or try to prevent them from reporting a work-place injury or illness, seeking medical care, or filing a workers' comp. An Act to Protect Injured Workers ers strengthens the anti-retaliation law, provides for complaint, investigation, and enforcement mecha nisms through the Attorney General's Office and a strengthened private right of action, and otherwise addresses employer misconduct that prevents workers from receiving timely medical care and benefits.

In this legislative briefing, Lenita was joined by Senator Jamie Eldridge, Lead Senate Sponsor; Representative Tram Nguyen, Lead House Sponsor; Al Vega, Director of Policy & Programs, MassCOSH; Ms. Audrey Richardson, Managing Attorney, Employment Law Unit, Greater Boston Legal Services; Diego Low, Director, MetroWest Worker Center/Casa; Emily Spieler, Edwin W. Hadley Professor of Law at Northeastern University School of Law; Bridget Quinn, Legislative Director, Massachusetts AFL-CIO; Michael Felsen, Senior Advisor, Justice at Work & Former Regional Solicitor, U.S. Dept. of Labor. The meeting covered an overview of the Act and stakeholders discussed the need to strengthen the workers' compensation anti-retaliation law. We are proud of Lenita and BWC for continuing to stand up for workers' rights in the workplace!

Building Justice, an initiative created in 2014 by the BWC and implemented in partnership with Justice At Work (J@W), aims to fight and support workers against wage theft. This equal partnership initiative is co-facilitated by BWC's Executive Director, Lenita Reason, and J@W's Tom Smith.
