The Brazilian Worker Center is proud to have hosted a cohort of young Brazilian immigrants during yet another edition of the Summer Dreamers Fellowship Program. The program is an initiative in partnership with the City of Boston and other non-governmental organizations in Massachusetts. Our Dreamers consisted of young immigrants, between 14 and 20 years old, who participated in classes taught in Portuguese at the BWC. Through the project, they collaborated with each other and learned about marketing, finance, emergency preparedness, and other topics.

For Dreams to happen, we count on several partnerships and the support of our local MA community. This past month, our project has received the support of two local restaurants. On August 3rd, we had the donation of Alex's Kitchen, a Brazilian restaurant located at 107 Nichols Ave in Watertown, which provided a delicious lunch for our participants. On August 8th, our Dreamers greatly appreciated the generous donation of seven pizzas from Domino's pizza (@dominos).

In August, our youth also had the opportunity to learn a variety of topics from our facilitators. Our Immigrant Defense and Domestic Workers Coordinator, Lorrayne Reiter spoke about immigrant rights; Jaime Zimmer, Executive Vice President of Five Rights Financial, spoke about financial education and Rony Jabour, Founder and CEO of United Safety Net, contributed, once again, with classes on Prevention of Building Falls, Infectious Diseases and protection against COVID-19. Our Dreamers project was also graced by the presence of Peter Barletta, Department of Labor Compliance Assistance Specialist (DOL - OSHA) and Adriane Queiroz, Program Assistant at (DOL - OSHA) USA; they came to honor and get to know our program during their visit. We would like to thank all who contributed to the Dreamers project Summer edition and we are grateful for our community's continuous support.



## Interview to the Radio 'Nossa Radio'



In support of the promotion of the Dreamers Fellowship program, the BWC's Safety and Health Project Coordinator, Gizele Bombardier, gave an interview to the local Brazilian radio station, 'Nossa Rádio', on August 5th. During her interview, she presented the purpose and importance of the Dreamers project, and she elaborat ed on ways that the project offers opportunities to the Brazilian immigrant youth and how it can impact our overall Brazilian immigrant community. On August 20th, the Building Justice Committee of the Brazilian Worker Center together with our partner Justice At Work, organized for the first time, a football championship that brought together members from seven organizations that collaborate with us in the defense of workers' rights. The Soccer and Solidarity Championship was held at the American Legion Playground in East Boston and was the first ever Annual Football Tournament and Family Day. This event not only enabled integration and fraternization among all who attended, but also made it possible to strengthen ties between the participating organizations.

The partner organizations that attended the event were Centro Comunitário de Trabalhadores (CCT), Cosecha, Justice At Work, Massachusetts Coalition for Occupational Safety & Health (MassCosh), Pioneer Valley Worker Center (PVWC of Springfield), Building Justice and Brazilian Women's Group, who did not bring a team, but was present throughout the event.

It was with great satisfaction that we celebrated the victory of the Building Justice team at the end. We would like to congratulate the organizations that received awards corresponding to second and third place, PVWC and Cosecha. We are excited for the next edition of the tournament and encourage everyone to follow the BWC on our social media to learn more about our upcoming events and programs.



### The Women of the BWC

In August, we also had the pleasure of bringing together and celebrating the Brazilian women who participate in two BWC programs, i.e. Domestic Workers and Mulheres Vencedoras, during our first Women's Dinner since the pandemic. While participants who attend our Domestic Workers program learn about their labor rights and how to organize; immigrant women who participate in our 'Mulheres Vencedoras' program, mostly cancer survivors and women with chronic illnesses, are invited to engage in activities that encourage well-being and social interaction.

The Dinner was generously donated by local restaurants Sabor do Brasil, Oliveira's Deli, Pastelaria Vitória and The Cheesecake Factory. The event was also attended by cardiologist Filipe Moura, MD, PhD. After dinner, he gave a lecture on the importance of habits that help the health of the cardiac and overall body system. Our participants and the BWC would also like thank Bella Mia Flowers, for presenting us and our participants with beautiful flowers and the author Alexandre Simoes, who kindly offered copies of his book during the gift giving portion of our event.
