### Building Work Power All Day, Every Day

On September 5th, the Brazilian Worker Center team participated in the Labor Day 2022 - Building Worker Power All Day, Every Day event organized by the Greater Boston Labor Council (AFL-CIO). The event took place at Park Plaza Hotel and was graced by the presence of important members of our community and leaders, including the mayor of Boston, Michelle Wu, the General Attorney of Massachusetts, Maura Healey, and the Vice President of the United States, Kamala Harris. Representatives, senators, unions, and workers also joined the event. After breakfast, we joined a march that walked from the Boston Public Garden to Downtown. The march supported Workers at the Hyatt Centric, who have been negotiating for their first contract for a year and a half.

#### Celebrating Brazil's Bicentennial

On September 8th, the Brazilian Consulate in Boston conducted a lyric recital in celebration of Brazil's bicentennial. The Brazilian Worker Center attended the event alongside other members of our Brazilian community in Massachusetts. warmest gratitude to our General Consul, Mr Benedicto Fonseca Filho for inviting us to join this amazing event.




#### **Brazilian Independence Festival**






On September, 15th, Lorrayne Reiter, Domestic Workers Organizer & Immigrants Defense Project Coordinator, conducted a Zoom training for 10 domestic workers. During the online session, the participants learned about how to advocate for better working conditions, about workers' rights as domestic workers, minimum salary in Massachusetts, and how to formally submit a complaint against employers who don't respect labor rights. Our Domestic Workers' Training happens every month and gathers female working professionals who work with cleaning services, babysitting, elderly caretakers and others. Our Workers' Rights programming represents the cornerstone of our work and we are proud to continue to serve our immigrant community with the necessary tools and resources needed to empower themselves as productive members of our communities. ## Planning for our Future



The Brazilian Worker Center believes that a multi-layered and systemic approach to workers rights' is the best and most reliable way of transforming social injustices in our state. For this reason, we collaborate with local partners to research issues associated with workers rights and social justice. As part of this commitment, the BWC has been partnering with Boston College's Civil Rights Clinic, since 2020, to better understand the impact of the Law that protects domestic workers on our immigrant community in MA. This Law passed due to the BWC's coalition work and this research will provide us with important information that will serve to guide our continuous efforts to contribute to our local community. On September 23rd, our Executive Director, Lenita Reason, and BWC's Workers Rights & Research Coordinator, Andrė Simōes, attended the virtual conference organized by the BC-CRC-BWC research group. We are excited to share our findings with the community and continue to fight for domestic workers rights!

# Engaging with our Community

The Brazilian Worker Center is proud of our long history as active members and advocates for our local immigrant workers in Massachusetts. As part of our efforts to promote the betterment of our community, we engage in social actions around the state, during which we have a chance to expand our community outreach and bring our services to various locations around the state. On September 25th, Workers Rights & Research Coordinator, Andre Simoes, and Domestic Workers Organizer & Immigrants Defense Project Coordinator, Lorrayne Reiter participated in a social action at a local Baptist church in Everett. During this social action, the community benefited from the distribution of food, vaccines, testing for infectious diseases, processing of Brazilian passports among other services. Lorrayne and André provided community support services to individuals attending the event, such as sharing information about how to proceed when having an immigration court scheduled with the Department of Justice via EOIR system,



as well as general information about the BWC's training for immigrant workers.





# Women First

As part of the Brazilian Worker Center's commitment to women empowerment, we make sure to attend local events that aim to reinforce this agenda, particularly those held and organized by local institutions and organizations. On September 27th, our BWC staff, Paula Correa, Community Outreach Coordinator and Lorrayne Reiter, Domestic Workers Organizer & Immigrants Defense Project Coordinator, participated in the event organized by the Brazilian Center in Boston with local women who are leaders in our community. During this event, the organizers discussed about Setembro Amarelo, and pro-

vided testimonies from survivors and health professionals to promote ways of preventing depression and suicide. # The Power of Labor

On September 28th, Lorrayne Reiter, BWC's Domestic Workers Organizer & Immigrants Defense Project Coordinator, participated in the Power of Labor meeting held in MCLE New England. During this meeting, Secretary of Labor, Marty Walsh talked about the importance of the labor movement in Massachusetts, as well as its impact on the advancement of workers rights. Among topics discussed, he mentioned future projects that are included in the federal government's pipeline.
