Knowing labor rights is essential for immigrants to avoid being victims of salary theft and other rights violations. With that in mind, we conduct our Know Your Rights Workshop every two weeks to answer questions and share information about workers' rights, regardless of their immigration status.

This year, the BWC has already held four workshops attended by 40 workers, who also use this opportunity to share issues that occurred in their workplace. According to André Simões, coordinator of the Department of Labor Rights, in addition to receiving instructions about how to conduct themselves in the workplace, some participants also filed a labor law-suit to recover salary theft.

Held in person at the BWC headquarters, the workshops have attracted workers from different parts of Massachusetts, such as Brockton, Allston, Framingham, Malden, Stoughton, Everett, Revere, and Boston, among others.

# The podcast highlighted how to avoid wage theft

Wage theft, mainly among immigrants, was the subject of the second episode of the Brazilian Worker Center Podcast, held in partnership with the Brazilian Times. The chat, coordinated by Alexandre Simões, highlighted this as one of the main problems that affect Brazilian workers.

The guests on the podcast were André Simões, Coordinator of the Workers' Rights Department at BWC, and Hélio Moreira, a volunteer at the Workers' Committee at BWC Building Justice. During more than an hour of conversation, we described what characterizes wage theft and how



workers can prevent this problem or seek resolution when their rights are violated. One of the podcast's highlights was how workers could record hours worked.





#### Here are some tips from André Simões:

- Make a table on your cell phone or write it down periodically in a notebook: day of the week, month, entry and exit times, breaks, and hours worked in the day.
- Weekly, add up all hours worked
- It is possible to calculate the value of hours and overtime from the weekly hours.
- Also, remember to write down company information such as name, owner's name, manager, address, phone number, and address where you work.
- Tip: There are cell phone apps to record time, such as an electronic point. One of them is DOL:

## The BWC Achieved Certification in Training from NDWA

The Brazilian Worker Center obtained a graduation certificate for participating in the last stage of the "Dignity, Unit, Power Institute" retreat in Austin (Texas), promoted by the National Domestic Workers Alliance. A certificate was delivered to Executive Director Lenita Reason, who participated in all virtual training sessions throughout 2022. The retreat had its last in-person and closing session in Austin, TX. Our Domestic Workers' Rights Department Coordinator, Lorrayne Reiter, accompanied our director for this last session.

The training brought together leaders from dozens of organizations across the country. On occasion, the participants reviewed the concepts that were discussed in previous phases of the training, with emphasis on areas such as leadership development, organizations, and movements.

The retreat also covered new practices for transforming leadership that can support the development of future community organizers. In the end, there was a graduation ceremony.






# Our Tribute to woman

### Implementation of The Driver's License

Our Executive Director, Lenita Reason, continues to serve as Co-Chair of the Driving Families Forward coalition, participating in weekly executive committee meetings to ensure we successfully implement the law.



In February, she participated in an important meeting with the Attorney General's Office transition team and already has a meeting scheduled for the first week of March with the RMV. Coalition lawyers are preparing an explanatory pamphlet, and with the help of BWC and SEIU, 32BJ will be translated into Portuguese and Spanish. Our goal is to make a version in other languages.
